## Funding and Budget for Morgan County Producers

The discussion focused on the financial support received by Morgan County producers from federal programs, totaling \$1.9 million, and the need for additional funding to maintain office operations. The speakers highlighted the impact of drought relief efforts and the necessity of securing more funds to sustain their work.

## 1. Request for Increased Funding

The speakers requested an increase in funding from \$22,000 to \$30,000 to cover operational costs and salaries. They emphasized the importance of this funding to keep the office running and avoid job losses.

### 2. Historical Funding Levels

There was a discussion about the historical funding levels, noting that funding was significantly reduced after the 2008-09 crisis. The speakers suggested finding past funding data to inform new board members.

### 3. Impact of Tax Hike

The potential impact of a tax hike on landowners and the community was discussed, highlighting concerns about its effects on those served by the office.

# Jeff Babcock, IT Administrator

The IT Director met virtually with representatives from Zoho Mail to discuss the features and pricing plans of their e-mail service. The County will need to purchase separate e-mail hosting when it moves to its new domain in the near future. HostGator, the County's current e-mail and website host, no longer has e-mail plans with sufficient disk space for the County's use. Zoho Mail is reasonably priced and feature rich, but is not based in the US. The IT Director is currently waiting for information from the Department of Homeland Security's Cyber Infrastructure Security Administration about the use of Zoho Mail for county government business.

Two new computers were placed online in the Recorder's office this week. All employee computers in the Recorder's office have been updated to Windows 11 at this point. Now, the public search computers will need to be updated to migrate away from Windows 10.

The IT Director is awaiting information from CORSA regarding a copy of their County policy manual template. CORSA, the County's liability insurance provider, offers a stock policy manual that has been reviewed by legal counsel that Ohio counties can use as a starting point for their own policy manuals. Additionally, once the policy manual is updated with the county specific items, CORSA will review the updated manual free of charge. The IT Director printed off the class material for the National Incident Management System and Incident Command System classes through the Emergency Management Agency. Completion of these two classes as well as the Public Information Officer class are required by EMA to serve as a Public Information Officer for the County.

WHEREAS, the Village of Crooksville has Emergency Medical Services (EMS) physically situated in close proximity to York Township, Morgan County, and is therefore able and desires to provide York Township with Emergency Medical Services (EMS); and

WHEREAS, York Township lacks sufficient Emergency Medical Services (EMS) and therefore Morgan County desires the Village of Crooksville to provide York Township with Emergency Medical Services (EMS) for the health, safety and welfare of the residents of York Township; and

WHEREAS, the Ohio Revised Code under Section 735.053 allows for the Village of Crooksville to enter into an agreement to provide Emergency Medical Services (EMS) to York Township; and

WHEREAS, the Village of Crooksville did previously enter into an agreement to provide EMS Services to York Township, which agreement was entered for a period of two (2) years and is now up for renewal, and the Village of Crooksville and Morgan County have agreed to enter into another such agreement for a period of two (2) years, at a mutually agreed adjusted price increase; and

WHEREAS, upon the foregoing, the Village Council desires the Village of Crooksville, acting through its Mayor, Village Administrator and Fire Chief, to enter into a new agreement with Morgan County to provide Emergency Medical Services (EMS) to York Township pursuant to Ohio Revised Code Section 735.053 and as otherwise allowed by law. NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

SECTION 1. In accordance with Ohio Revised Code Section 735.053, the Village of Crooksville, acting through its Mayor, Village Administrator and Fire Chief, is hereby authorized and instructed to enter into a new agreement with Morgan County to provide Emergency Medical Services (EMS) to York Township, upon the terms and conditions set forth in said agreement, a copy of which is attached hereto and incorporated herein by reference.

SECTION 2. That this Resolution is declared an emergency measure necessary for immediate effectiveness on its passage in order to allow for timely effect pursuant to commencement date called for under the agreement and in order to provide funds necessary to the fiscally responsible and efficient administration of the Village's EMS Department, all in the best interests and general welfare of the Village of Crooksville. #### VILLAGE OF CROOKSVILLE/MORGAN COUNTY EMERGENCY MEDICAL SERVICES (EMS) CONTRACT FOR YORK TOWNSHIP

This Agreement made by and between the Village of Crooksville, Perry County, State of Ohio, acting through its Mayor, Village Administrator and Fire Chief, hereinafter referred to as the "Village," and the County of Morgan, State of Ohio, acting through its Board of County Commissioners, hereinafter referred to as the "County" (Collectively, the "Parties"). *Witnesseth:* 

WHEREAS, the Village has Emergency Medical Services (EMS) physically situated in close proximity to York Township, Morgan County, and is therefore able and desires to provide York Township with Emergency Medical Services (EMS); and

WHEREAS, York Township lacks sufficient Emergency Medical Services (EMS) and therefore the County desires the Village to provide York Township with Emergency Medical Services (EMS); and

WHEREAS, to that end, it has been resolved by the Village Council to enter into this Agreement between the Village and the County for Emergency Medical Services (EMS) for York Township pursuant to Ohio Revised Code Section 735.053 and as otherwise allowed by law; and

WHEREAS, to that end, it has been resolved by the Morgan County Board of County Commissioners to enter into this Agreement between the Village and the County for Emergency Medical Services (EMS) to York Township pursuant to Ohio Revised Code Section 307.05 and as otherwise allowed by law.

NOW, THEREFORE, in consideration of the promises and the covenants and agreements herein set forth, the Parties hereto agree as follows:

1. The Parties hereby incorporate the above statements into this Agreement.

2. The Village agrees to provide Emergency Medical Services (EMS) to the County's York

Township and York Township's residents for a period of two (2) years beginning the 1<sup>st</sup> day of January, 2025, and ending the 31<sup>st</sup> day of December, 2026, or upon the mutual reevaluation by the Village and the County.

3. The Village and the County agree that said Emergency Medical Services (EMS) shall be provided under the direction and supervision of the Village's Fire Chief, hereinafter referred to as the "Village Fire Chief," who shall be in charge of the overall operation of providing Emergency Medical Services (EMS) to York Township and who shall be appointed by and be under the direction of the Village Mayor and Council. The Village Fire Chief shall be responsible to see that all personnel are trained in accordance with State regulations applicable to Emergency Medical Services (EMS) when obtaining their EMS certification, including any refresher training required to maintain present status. Cost of EMS certification training, refresher training, including special training, which shall include only the costs of instructor's fees, manual, workbooks, and special equipment needed for said training, and registration fees for said training, shall be paid by the Village in accordance with its personnel rules. The Village's proper operation of said Emergency Medical Services (EMS), the cost of which shall be covered by the Village, within the County's per run payment for said service.

4. The County promises and agrees to pay to the Village for said Emergency Medical Services (EMS) provided for the duration of this Agreement the sum of One Hundred Twenty-Five and No/100 Dollars (\$125.00) per Emergency Medical Services Run ("EMS Run") within York Township, Morgan County, Ohio. The Village will provide the County an invoice every six (6) months, listing the EMS Runs made by date, time and address, together with the total amount due for the EMS Runs made within that six-month period. The County shall make payment to the The undersigned, Fiscal Officer of the Village of Crooksville, Perry County, Ohio hereby certifies that funds are available, or in the process of collection, sufficient to meet the requirements of this Agreement for the Village.
