9-1-1 Report to Commissioners, 12/30/2024

- Continuing to work with Interaction Insight, Sundance and ComTech on technical issues with integration.
- John Telesz inspected the old Transit building for suitability for the Emergency Communications Center. I have not yet received his report.
- Weekly Readiness Call with ComTech 12/17 and 12/24 – Tentative training and deployment schedule remains the same: Admin training for Sheriff, Coordinator and lead dispatcher 1/14/25, Call-taker training 1/15/25 and 1/16/25. ATP testing 1/20/25, 1/24/25 and 1/31/25. Deployment/migration 2/4/25.
- Continue working with APCO for Intellicomm implementation, guidecard review, training, etc. Implementation call canceled due to my absence. Rescheduled for 12/30 @ 14:30 hrs.
- SO now has 9 FT and 1 PT telecommunicators, but one of the experienced telecommunicators is leaving due to an employment opportunity outside of 9-1-1.
- Discussion with ComTech regarding “admin” lines. These are 10-digit phone numbers that will ring in through the 9-1-1 call handling equipment (CHE). In discussions with the soon-to-be Sheriff the decision is to utilize 962-2222 and 962-3333 as the admin lines. These are the “old” 10-digit emergency numbers and are still published in phone

directories as emergency numbers. 962-2222 is currently an M&M number, but will be ported to the CHE – relieving M&M of the expense for this number.

- Received quote from eDispatches for 9-1-1 to assume the service for the County. The cost will be about \$1400 up front and \$3000 annually. This will serve as tertiary notification for 9-1-1 and will save the expense from each fire department.
- There is an EMS issue regarding bariatric patients that has spilled over to 9-1-1. Riverside Landing has multiple bariatric patients and M&M EMS cannot safely transport them. RL is under the impression that it is a 9-1-1 issue to locate transportation services for them. Attached is an email I wrote regarding this as well as a response from Captain Woodward from M&M EMS. As you will see in the email the County needs to get clarification on some issues regarding this from the Prosecutor, both from a 9-1-1 and EMS perspective.

LEPC Meeting

The LEPC meeting is scheduled for January 8th at 11:30 AM. The commissioners have a land bank meeting at 10:00 AM and will join the LAPC meeting afterward.

Emergency Communication Center

Discussion on the suitability of the old transit building for the emergency communication center.

Telecommunicator Staffing

One experienced telecommunicator is leaving, and there are discussions about filling the position. Admin lines will be updated to use old emergency numbers.

E-dispatches Service

A quote was received for e-dispatches service for 911, costing \$1,400 upfront and \$3,000 annually, which will save expenses for fire departments.

EMS and Bariatric Patients

Riverside Landing is accepting bariatric patients, but M&M EMS lacks the equipment to transport them. Discussions are needed to clarify responsibilities.

Fire Department Grants

Fire departments need to participate in an orphans fund to be eligible for state grants. It's unclear if all departments are participating.

Julie Gridley, Pound Keeper

Donations and Supplies

Ms. Gridley discussed the receipt of donations from various sources, including Tractor Supply, Family Dollar, and a local class. These donations included food, toys, and a wheelbarrow, which were appreciated and necessary for their operations.

Gratitude was expressed for the donations, which have significantly helped their operations.

Maintenance and Complaints

Ms. Gridley mentioned issues with rusted kennels and the high cost of spray paint. There were also complaints about the cleanliness of the facility, which she defended by explaining their cleaning procedures.

Ms. Gridley plans to address the complaints and consider alternatives for maintenance costs.

Staffing Issues

Ms. Gridley expressed frustration with a staff member's unreliability, citing missed shifts and communication issues. She also sought permission to let the staff member go due to these ongoing problems.

She received permission to terminate the staff member's employment.

Adoption Fees and Donations

Ms. Gridley reported collecting \$280 in adoption fees and additional donations, which will support their operations.

The funds collected will be used to support the facility's needs.
