Sophia Whisman- 4-H Extension Educator

Late January Sophia started working on a management of volunteer training course to help guide her in the management of our volunteers. This is a course open to educators in the U.S. promoted by our state 4-H leaders to help in our role as the volunteer manager. January 31st was our deadline to apply to be a new volunteer. We received 4 applications for new volunteers this year. February 3rd and February 5th Sophia held new volunteer interviews we she interviewed all 4 applicants. February 4th Sophia traveled to Columbus to attend a 4-H professionals Inservice with Pam Montgomery to receive an update from the state 4-H office on the 4-H program moving into 2025. February 7th Sophia was on WHIZ live at noon promoting 4-H. February 13th Sophia sat down with Pam Montgomery and an audit committee to start auditing 4-H clubs at random for the past three years. Also, on February 13th Sophia had new volunteer orientation where all new volunteers got their required training to begin their roles in 2025 as Morgan County 4-H volunteers. February 17th Sophia and Pam Montgomery held 2 sessions of our mandatory advisor update. All returning 4-H volunteers must attend one f these sessions to renew their status.

This month so far Sophia has attended Junior Fair Board and Senior Fair Board meetings.

This month Sophia will continue prepping for the older youth groups kicking off and working on prepping QA and Skillathon study guides.

Pam Montgomery-4-H/FCS Extension Educator and Area Leader

In the past month she has been working to 4-H Camp Counselors to complete the annual required training. 4-H CARTEEN members have held their first program for 2025 for first time Juvenile traffic offenders. 4-H Fashion board held their first meeting February 3rd and members learned basic hand stitches. She is assisted with 4-H Volunteer update and interviewing and training new volunteers for the 4-H Riding Therapy program. sub-committee, and trainings for Camp Counselors. In the Family and Consumer Sciences program area Pam has scheduled Successful Co-Parenting classes, Active Parenting classes, and basic household budgeting classes for 2025. She is still working with her co-presenter to set a schedule for Matter of Balance to be offered later in the year.

As the Area Leader for Morgan, Muskingum, Perry, and Washington Counties she continues to have one-on-one meetings with the staff members she is supervising in the counties, attends staff meetings, and Extension Advisory Committee meetings when requested. She also attends 2 monthly Area Leader Zoom meetings.

January 24, 2025, Moore attended the office staff meeting. Language and ComTech Issues

Discussed ongoing issues with ComTech and the integration of new language into their systems. Despite challenges, the 911 operations are functioning well, and staff are becoming proficient.

CAD System Usage

Jeff Babcock, IT Administrator

Common Pleas Court is planning to start a day reporting program for probationers. They are going to temporarily set this up in one of the second floor witness rooms of the Courthouse. The long-term plan is to renovate the large meeting room in the Courthouse basement for this program. Neither room they plan to use has sufficient network or phone connections to support multiple computers and the basement meeting room has only one power outlet, which is right next to the door. The temporary room can make use of the second floor's wifi access point, which is right across the hall, but a contractor will need to install more power and network drops in the basement meeting room before it can be used.

Morgan County Public Transit has seven vehicles (four vans and three buses) that are excess to needs and were placed on the GovDeals auction site for sale to the public. The IT Director discussed the possibility of using GovDeals for the sale of other excess items around the County with the Commissioners.

The IT Director worked with Brightspeed in an effort to port the Sheriff's office and firehouse emergency numbers into the 911 system. However, the initial request to receive the numbers was never set up by Comtech, the new 911 service implementers. Troubleshooting is ongoing.

MEMORANDUM OF UNDERSTANDING

This Agreement is entered into between the Morgan County Board of Commissioners "Commissioners" a local government, located at 155 E Main St, McConnelsville, Ol1 43756, and The Ohio State University on behalf of its Morgan County Extension Office ("OSU"), located at 155 E. Main St., Suite 320, McConnelsville, Ol1 43756.

WHEREAS, pursuant to Ohio Revised Code Section 3335.37, County Tax Levy for OSU Extension Fund, the Morgan County Board of Commissioners has appropriated funds from certain tax levies to support the OSU Extension Fund created by Ohio Revised Code Section 3335.35.

WHEREAS, the appropriated funds have been accumulating and have not been used by the Morgan County Extension Office;

WHEREAS, the Parties have agreed to use up to \$100,000 of the appropriated fund to renovate and upgrade the building occupied by OSU, as further described below, in support of Morgan County Extension. Further the Commissioners have agreed to not assess any financial penalties or claw back funds unused by OSU.

NOWTHEREFORE, the Parties agree as follows:

Commissioners shall install new windows, carpeting and paint the office interior, to the extent which allocated funding permits. All renovations or upgrades will inure to the benefit of OSU. The parties shall continue to extend the related agreement permitting OSU to occupy the space and outline responsibilities of OSU's tenancy.

OSU agrees to transfer excess levy funds to line item N08 OSU Extension Learning Center after the first half tax settlement each year. The transferred funds are to be used exclusively for maintenance and upkeep of the learning center facility.

Five (5) companies submitted bids on Fourteen (14) different aggregate materials (See attached list).

Shelly & Sands Aggregate was low bidder on the gravel products. Although we do not use a whole lot of gravel; this will be our location to purchase any gravel products

Four (4) companies, Shelley Materials, Melvin Stone, Cumberland Limestone. And Maysville Materials submitted bids on the crushed stone portion of the bid request. Shelly Company now owns Cumberland Limestone, Shelly Materials, and Maysville Materials. Price increases are overall in the +/-5% range.

However, when trucking costs are brought into the equation Melvin Stone has the best overall delivered costs when "good" stone is required southwest of McConnelsville. If good stone is not a controlling requirement Shelly Company has the best value.

Since job location, haulage costs, and job aggregate requirements will vary on a daily basis; it is my recommendation that all the bids be accepted and usage will be based upon location, and job requirements to obtain the most overall cost effective results for the materials and transportation to a given location.
