Fire Department and Village Water Tower Lease

The fire department is charging \$600 a month for a small building used for amplifiers, which is considered excessive. There is concern about potential additional charges for antenna use on the water tower.

Alternative Tower Options

Options include negotiating with the fire department, using the county tower, or building a new tower on a ridge for better transmission capabilities. The ultimate solution is to improve transmission for transit and the sheriff.

Engineering Inspection and Costs

An engineer from Cleveland proposed an inspection costing \$71,000. Inspections and dives are required every other year, costing \$30,000, with next year's costs estimated at \$70,000 to \$100,000.

County Road Map and Internet Map

A new printed map of county roads is being created, along with an internet map that can be updated frequently. Businesses can advertise on the internet map for \$100, covering four to five years.

Dog Adoption Process

The discussion revolved around the process of adopting dogs from their owners and ensuring they are not fed before being brought to the pound. There is a mention of a person who seems to want control over the adoption process, which causes tension among the team.

Authority and Responsibilities

There is a debate about the roles and responsibilities of different individuals involved in the dog pound operations, particularly concerning the above-mentioned person's authority and the legal obligations regarding holding dogs from the humane society.

Radio and Tower Issues

The discussion focused on resolving radio communication issues in the county, including leasing space on a tower controlled by SBA and the impact of T-Mobile's transmitters. The need for technical data to proceed with leasing and the potential relocation of equipment were highlighted.

Fire Department and Antenna Leasing

The conversation addressed the financial aspects of leasing antennas on village property, questioning the fire department's authority to charge fees. The possibility of using a generator as a bargaining chip was also discussed.

911 Dispatch and Training

The meeting discussed the training of 911 dispatchers and the transition of responsibilities to the fire department. The need for improved accuracy in dispatching was emphasized.

Fire Service and Mutual Aid

The discussion touched on the future of paid fire services and mutual aid agreements. The need for better coordination and response times was highlighted.

Shannon Wells, Development Office

The HB2 Jail Grant Application for jail rehab was submitted and confirmed received by Department of Rehab and Corrections on February 28, 2025.

Whereas, the County of Morgan seeks to repair and/or replacement of failing home sewage treatment systems; and

Whereas, the County of Morgan intends to apply for Water Pollution Control Loan Fund (WPCLF) for the repair and/or replacement of failing home sewage treatment systems; and

Whereas, the Ohio Water Pollution Control Loan Fund requires the government authority to pass legislation for application of a loan and the execution of a WPCLF loan agreement; now therefore,

BE IT RESOLVED by the Board of County Commissioners of Morgan County, Ohio:

SECTION 1. That the President of Morgan County Commissioners be and is hereby authorized to apply for a WPCLF loan, sign all documents for and enter into a Water Pollution Control Loan Fund with the Ohio Environmental Protection Agency for the repair and/or replacement of failing home sewage treatment systems on behalf of the County of Morgan, Ohio.

SECTION 2. That is resolution shall take effect and be in force from and after the earliest period allowed by law.

Jeff Babcock, IT Administrator

After much research, it was decided that Microsoft 365 Business Basic would be the best service for e-mail for the County's new domain, morgancountyohio.gov. This plan uses Microsoft Exchange as the mail server and will offer a host of Microsoft service, including Outlook, Teams, and Booking. The IT Director has a meeting scheduled with Microsoft to clarify some of the features of the Business Basic plan, such as group e-mail accounts, shared calendars, and room booking.

The IT Director has been working with Spectrum to upgrade the fiber Internet contract at the Courthouse. While meeting with Spectrum regarding the upgrade of Internet at the Sheriff's office, it was mentioned that the County could upgrade their service in the middle of their contract, if we add or change services. The IT Director is trying to add a firewall from Spectrum at the Courthouse and renew the contract at a lower rate.

The Commissioners sent documentation to the IT Director, who also co-chairs the County's Safety Committee, about CORSA's Loss Control Incentive Program (LCIP) and the LCIP Bonus program. These programs will apply rebates to the County's CORSA dues if certain action items are completed prior to January of next year (CORSA is the County's liability insurance provider). The County's Safety Committee will review these programs and attempt to implement as many of them as possible in 2025.
